Nigel has resorted to a multitude of excuses regarding business interests that contradict the image of him as "a man of the people." In reality, he is quite the opposite, and it is almost comical how easily some individuals are swayed by his contrived persona—complete with his casual beer drinking, cigarette smoking, and country attire—while he pretends to care about societal issues rather than focusing on his own financial gain.

The timeline presented below is crucial in illustrating the man's thought process as a law-abiding citizen who believes in the integrity of others. He attempted to conceal his taxes, and when exposed, he claimed ignorance regarding the matter until it was revealed that he had signed the cheques to establish the company in the Isle of Man. This reaction reflects his character; when confronted, he resembles a deer caught in headlights, evading challenging questions or resorting to falsehoods. Notably, he only acknowledged the situation after being caught.

The company in question is Farage Limited just one of many companies Nigel Farage is or has been a director in.

Timeline

1999 Nigel Farage elected to European Parliament

February 2003 Farage, his brother Andrew Farage and a third director set up commodity trading firm Farage Limited.

August 2003 A document filed at Companies House stated that Nigel Farage owned no shares in Farage Limited and the Farage Family Educational Trust 1654 owned 33 shares.

May 2004 Another document filed at Companies House stated that Nigel Farage owned 33 shares in Farage Limited and the Farage Family Educational Trust owned none.

October 2004 Farage was appointed company secretary of Farage Limited.

February 2006 Farage resigned as director of Farage Limited but remained as company secretary.

September 2006 Nigel Farage became leader of UKIP.

November 2009 Nigel Farage stood down as UKIP leader.

November 2010 Farage was re-elected leader of UKIP.

May 2010 Farage failed to win a seat at Westminster in the general election.



The timeline presented below is crucial for understanding the man's thought process as a law-abiding citizen who believes in the integrity of others. He was discovered attempting to conceal his taxes, and upon being confronted, he asserted that he was largely unaware of the situation until it was revealed that he had signed the cheques to establish the company.



This indicates that Nigel was involved in the company's formation from the outset, while simultaneously investing his 33% shareholding into another company he established concurrently in the Isle of Man.

The company's financial records indicate that Andrew, who holds a 50% ownership stake, withdrew £969,000 in dividends over a lengthy period yet surprisingly Nigel did not think to question the companies bank accounts in which he held a 50% stake through his trust. To clarify, Andrew, who had a

close relationship with his brother, received nearly £1 million, whereas Nigel's trust did not receive any funds. Following this, Nigel resigned as secretary, despite still owning the trust, and backdated his resignation. Notably, he continued to sign filing documents after this supposed resignation. His resignation occurred on a Sunday, a day when it is not typical for accountants to file documents on behalf of clients; however, the registration of this resignation took over 12 months.

Notification Period: The company must inform Companies House within **14 days** of the resignation². This is done by completing and submitting the appropriate form (TM02 for company secretaries).

Backdating Resignation: It is possible to backdate a resignation. When submitting the resignation, you can enter the actual resignation date in the "Resignation Date" field. However, it's important to ensure that the backdated resignation is accurate and reflects the true date of resignation to avoid any legal complications

As the company entered liquidation, Farage Limited reached an agreement with HMRC to repay outstanding taxes. Nigel Farage stated in multiple interviews that the repayment would be made from his earnings. However, the Liquidator observed that the terms of the agreement were not fulfilled, resulting in Farage not repaying the taxes owed by the company.

The liquidator's report should highlight that Andrew Farage received £124,000 in dividends, which contributed to the company's liquidation due to its insolvency. This situation coincided with Nigel Farage's backdated resignation.
