## URGENT: Julia Wandelt

Good evening

I am a former Police Constable and since 2022 I have acquired irrefutable evidence of decades long international Government fraud, linked to apparent child trafficking, abuse, torture, murder and the harvesting of adrenochrome from children as well as its links to apparent sinister depopulation plans with vaccines and directed energy systems.

Almost all UK Police Forces and 650 Members of Parliament have been completely ignoring several more recent reports containing this evidence.
