Home Office estimates that the Illegal Migration Bill could cost between £3 billion and £6 billion over next two years. This includes:

- 1. Expenses for detention facilities
- 2. Ongoing accommodation
- 3. Removals

Additionally, the current asylum system costs the UK around £3 billion a year, with nearly £6 million a day spent on hotel accommodation for asylum seekers. These figures highlight the significant financial impact of managing illegal migration and asylum processes in the UK.

Comparisons:

Illegal_migrants based on UK government figures.

£6 billion

Military veterans receive funding split from 2 different channels (healthcare, housing and employment support)

£33 million

Winter fuel allowance £2 billion

The Illegal migrant contribution receives £3,967,000,000 more than the combined Military and winter fuel allowance.

With £4 billion, the UK could make several significant investments or purchases. Below are a few examples:

- 1. Public services fund approximately 588,000 state pensions for a year
- 2. Healthcare: Build and equip several new hospitals or significantly upgrade existing ones.
- 3. **Education**: Construct and maintain numerous schools or universities.
- 4. **Infrastructure**: Invest in major infrastructure projects like roads, bridges, or public transport systems.
- 5. **Technology**: Enhance digital infrastructure, such as expanding high-speed internet access across rural areas.



- 6. **Defence**: Purchase advanced military equipment or fund defence research and development.
- 7. **Housing**: Develop affordable housing projects to address homelessness and housing shortages.

Illegal Migrants arriving in the UK



Arrivals by boat across the channel vary significantly and the majority arrive during calm seas.

Example variances:

27 August 2024 – 525 migrants 28 August 2024 – 614 migrants

Average in 2024 is 138 per day

Companies awarded contracts by the UK government to provide housing and related services for migrants and asylum seekers are:

- 1) Serco Provides accommodation and support services for asylum seekers in various regions of the UK.
- 2) Mears Group Manages housing and support services for asylum seekers, particularly in Scotland, Northern Ireland, and parts of England.
- 3) Clearsprings Ready Homes Responsible for providing accommodation and support services in London, the South of England, and Wales.







These contracts are part of the Asylum Accommodation and Support Services Contracts (AASC) and are set to run for ten years, until 2029.



These companies are contracted to ensure that migrants and asylum seekers have access to necessary housing and support services while their applications are processed.

The tendering process for the Asylum Accommodation and Support Services Contracts (AASC) involved several major companies. Here are some of the notable companies that participated but did not win the contracts:

- 1. G4S Previously held contracts for asylum accommodation but did not win any contracts in the latest round.
- 2. Mitie Another major outsourcing company that participated in the tendering process.

Contracts signed off by were signed off by the Home Secretary, Priti Patel, in 2019.

The major investors in these companies are as follows:

BlackRock: Holds a significant stake in Serco.

Vanguard: Has investments in Serco. State Street: Owns shares in Serco.

Mears Group

BlackRock: Has investments in Mears Group. Vanguard: Holds shares in Mears Group. State Street: Owns a stake in Mears Group.

Clearsprings Ready Homes

Clearsprings Ready Homes is a privately owned company, so it does not have public shareholders like BlackRock, Vanguard, or State Street, unless the investments are formulated in a private capacity.

Unfortunately, the tender documents are not publically available, but financial overviews, including investors, would form part of the documents.

BlackRock, Vanguard, and State Street are known to have investments in many publicly traded companies, including those that participated in the tendering process but did not win the contracts:

<u>G</u>4S

BlackRock: Holds a significant stake in G4S.

Vanguard: Has investments in G4S. State Street: Owns shares in G4S.



Mitie

BlackRock: Has investments in Mitie. Vanguard: Holds shares in Mitie. State Street: Owns a stake in Mitie.

These investments reflect the broad portfolios of these major asset management firms, which often include a wide range of companies across various sectors.

The Asylum Accommodation and Support Services Contracts (AASC) awarded to Serco, Mears Group, and Clearsprings Ready Homes are set to run for ten years. These contracts began in September 2019 and are scheduled to continue until 2029.

I initially hesitated to include a conclusion, but it's important to stress that advocating for free speech and government accountability should not be shameful. I am a grandfather who has worked hard and fulfilled my tax obligations, and I now have a broader perspective. To reach a wider audience, I'm simplifying topics on my website. Unfortunately, TikTok has limited my posts, causing a loss of over 500,000 followers. However, our community is ready to launch a major initiative against the establishment, providing verifiable information that can't be easily dismissed. Everyone deserves a voice, and my website will evolve to allow visitors to download and share accurate documents.

While I've been involved in various investigations, my self-funding has limited resources. Soon, we'll offer products for purchase to cover operational costs, and I have no plans for a crowdfunding campaign to maintain transparency. If you choose to buy products to support our cause, I would be grateful. I've known remarkable individuals who lost their lives seeking justice, and I encourage you to watch my friend's documentary, "Fall of the Cabal," on Rumble.

September I'll be focusing on specific topics to clarify the complex landscape of information and I plan to host live sessions twice a week on a Tuesday and Friday at 9pm GMT commencing 24th September.
